

## City of Pleasant Valley Missouri Meeting of the Board of Aldermen August 29, 2016 Special Session

**Call to Order:** A special session meeting of the Pleasant Valley Board of Aldermen was called to order at City Hall, 6500 Royal, Pleasant Valley, Clay County, Missouri, by Mayor David Slater, on Monday, August 29, 2016 at 7:05 p.m. The City Clerk provided copies of the proposed ordinances and resolutions, for the public, prior to the meeting.

**Roll Call:** Present were: Mayor David Slater, Alderwoman Linda Jacoby, Alderwoman Mary Langner, Alderman Jim Menaugh, Alderwoman Ruth Mesimer and Alderman James Smith. Aldermen Rick Scarborough and John Higgins were not present. There is one position in Ward 3 that is vacant.

Staff present: Assistant City Clerk Deborah Crossley and City Clerk Georgia Fox.

**Public Comments:** No one from the public was present to address the Board.

**Aldermen Comments:** Alderman Menaugh suggested that the Kane Wheeler be removed from the new fire station without installing new letters that would say "Pleasant Valley". By doing this the sign would still read "Fire Station, 8108 Pleasant Valley Road". He said this would save additional expense to make the change. After some discussion, no motion was made to approve this suggestion. (City Clerk note: At the Aug. 1st meeting the Board voted to approve removing "Kane-Wheeler" and replacing it with "Pleasant Valley Fire Station")

## **Consideration of Ordinances, Contracts and Resolutions:**

**Council Bill 3227,** "An Ordinance setting the 2016 Tax Levy, real and personal property for the City of Pleasant Valley, setting the date Taxes shall be considered delinquent and setting the penalty for delinquent taxes", was read by title only by the City Clerk. Alderwoman Jacoby moved to approve the bill and place it on second reading. Alderman Smith seconded the motion. The vote was as follows: Higgins – absent, Jacoby – aye, vacant – n/a, Langner – aye, Menaugh – aye, Mesimer – aye, Scarborough – absent, Smith – aye. Motion passed.

**Council Bill 3227,** "An Ordinance setting the 2016 Tax Levy, real and personal property for the City of Pleasant Valley, setting the date Taxes shall be considered delinquent and setting the penalty for delinquent taxes", was read by title only by the City Clerk. Alderwoman Jacoby moved to approve the bill as Ordinance 3226. Alderman Smith seconded the motion. **Adjournment:** There being no further business, Alderwoman Mesimer moved to adjourn. Alderwoman Jacoby seconded the motion.
