Meeting of the Board of Aldermen
August 29, 2017
Special Session*

Call to Order: A special session meeting of the Pleasant Valley Board of Aldermen was called to order at City Hall, 6500 Royal, Pleasant Valley, Clay County, Missouri, by Mayor David Slater, on Tuesday, August 29, 2017 at 7:05 p.m. The City Clerk provided copies of the proposed ordinance, for public examination, prior to the meeting.
