Meeting of the Board of Aldermen  
October 1, 2018*

**Call to Order:** A regular session meeting of the Pleasant Valley Board of Aldermen was called to order at City Hall, 6500 Royal, Pleasant Valley, Clay County, Missouri, by Board President James Smith, on Monday, October 1, 2018 at 7:30 p.m. The City Clerk provided copies of the proposed ordinances and resolutions under consideration, for public examination, prior to the meeting.

**Pledge of Allegiance:** Bryce Reed from Boy Scout Troop 460 led the pledge of allegiance.

**Roll Call:** Present were: Mayor David Slater, Alderman Anthony Crawford, Alderwoman Linda Jacoby, Alderman Loren Jones, Alderwoman Mary Langner, Alderman Jim Menaugh, Alderwoman Ruth Mesimer, Alderman Rick Scarborough and Alderman James Smith.

Staff present: Police Chief Gordon Abraham, Public Works Director Chris Cronk, Court Administrator Sarah Everhart, City Clerk Georgia Fox and Assistant Fire Chief Alan Heyne.

**Consent Agenda:** Alderwoman Langner moved to approve the consent agenda. Alderman Scarborough seconded the motion. The vote was as follows: Crawford – aye, Jacoby – aye, Jones – aye, Langner – aye, Menaugh – aye, Mesimer – aye, Scarborough – aye, Smith – aye. Motion passed, 8 aye - 0 nay.

**City Attorney and other Professional Services:** No professional service providers were scheduled to appear and none were present.

**Public Comments:** No one from the public wished to address the Board.

**Mayor's Comments:** Mayor Slater did not have any comments to make.

**Aldermen Comments:** Alderwoman Langner reported that at the Park Board meeting 5 names were considered for the new park along the west side of Sobbie Road:

Alderman Scarborough briefly discussed the use tax flyer. The Board discussed the importance of adequately funding the new and existing city parks.

**Fire Department:** Chief Heyne announced that the Fire Department will do another American Red Cross smoke detector drive on October 13<sup>th</sup>.

Chief Heyne announced that Santa on the Fire Truck is scheduled for December 15<sup>th</sup>.

Chief Heyne also reported that the Fire Department will apply for an AFG grant for bunker gear and hose replacement.

**Police Department:** Chief Abraham reported that Claycomo and Pleasant Valley will host a Coffee with a Cop event at Ma and Pa's on October 3<sup>rd</sup>.

Chief Abraham reported that WDAF is hosting a fund raising event to donate bullet proof vests to police departments on October 4<sup>th</sup>. They will provide Pleasant Valley with two vests. Chief Abraham has volunteered to help staff the event.

**Municipal Court:** Court Administrator Everhart did not have anything to report at this time.

**Personnel Committee:** Alderwoman Jacoby, Personnel Chair, moved to approve the hire of Sarah Kahmann, as full time Police Officer, step 6, \$20.00 per hour, pending background checks, physical and drug test. Alderwoman Mesimer seconded the motion. The vote was as follows: Crawford – aye, Jacoby – aye, Jones – aye, Langner – aye, Menaugh – aye, Mesimer – aye, Scarborough – aye, Smith – aye. Motion passed, 8 aye - 0 nay.

**Finance Committee:** Alderman Crawford, Finance Chair, had nothing to report at this time.

**Old Business:** No old business was discussed.

**New Business:** No new business was discussed.

**Consideration of Ordinances, Contracts and Resolutions, Continued:**

Alderwoman Jacoby moved to place **Council Bill 3308** on first reading. Alderman Scarborough seconded the motion. The vote was as follows: Crawford – aye, Jacoby – aye, Jones – aye, Langner – aye, Menaugh – aye, Mesimer – aye, Scarborough – aye, Smith – aye. Motion passed, 8 aye - 0 nay. The City Clerk read the bill by title only, “An Ordinance approving the Redevelopment Project of the Pleasant Valley Tax Increment Financing Redevelopment Plan as a Redevelopment Project and adopting tax increment financing therein.”

Alderwoman Langner moved to place **Council Bill 3308** on second reading. Alderman Crawford seconded the motion. During discussion, Alderman Scarborough moved to table indefinitely Council Bill 3308. Alderman Jones seconded the motion. The vote on the motion to table the bill indefinitely was as follows: Crawford – aye, Jacoby – aye, Jones – aye, Langner – aye, Menaugh – aye, Mesimer – aye, Scarborough – aye, Smith – aye. Motion passed, 8 aye - 0 nay.

**Adjournment:** There being no further business, Alderwoman Mesimer moved to adjourn. Alderwoman Jacoby seconded the motion. The vote was as follows: Crawford – aye, Jacoby – aye, Jones – aye, Langner – aye, Menaugh – aye, Mesimer – aye, Scarborough – aye, Smith – aye. Motion passed, 8 aye - 0 nay. 7:47pm
