2. **RESIDENCY:** I will notify the Court and/or Probation Officer of any changes in my residency within 48 hours.
3. **DRUGS:** I will not have in my possession or use any controlled substance except as prescribed for me by a licensed medical practitioner.
4. **REPORTING/DIRECTIVES/PROBATION COSTS:** I will report as directed to my Probation Officer. I agree to abide by any directives given to me by my Probation Officer. I further agree to pay the costs for my probation and for any programs/classes required to attend.

- 6.( ) **SATOP:** I will attend a Substance Abuse Traffic Offender Program assessment within 45 days and comply with that programs recommendations within 120 days.
