Section 630.090 No Visit List.

The City Clerk will maintain a list of persons within the City who restrict visits to their residential property (including their leasehold, in the case of a tenant) by peddlers. This "no visit" list is a public document, reproduced on the City's website, and available for public inspection and copying. A copy of the "no visit" list will be provided to each applicant for and each recipient of a permit. Failure to abide by the "no visit" list constitutes grounds for revocation of the permit and a fine in accordance with Section 615.200 of the Code.
