

PLEASANT VALLEY POLICY CHANGE AS OF 7/1/2017

If your client meets the below qualifications, and you are not in need of a continuance, please take the file and defendant(if applicable) downstairs to the Court Clerk, you are able to pay out these citations with the clerk without a review of the file from the Prosecutor first.

If your file has an **ORANGE** paper on the front of it, you **MUST** see the Judge.

NO EXCEPTIONS UNLESS THE JUDGE STATES OTHERWISE.

Court Costs are \$27.50

Walk- In Amendments are by Credit card, or Mail in-law firm checks (with prosecutor's prior approval) **ONLY**.

PROCEDURES FOR WALK-IN AMENDMENTS
FOR OFFENSES ON OR AFTER OCT 2017

An attorney licensed to practice law in the State of Missouri may request the Pleasant Valley prosecuting attorney to amend certain violations in advance of any court appearance. At the prosecutor's discretion, the violation may then be amended without a court appearance and a receipt will be mailed, faxed or emailed to the attorney of record.

To be eligible, the defendant must:

1. NOT have a commercial driver's license.
2. Not have been involved in an accident.
3. Have a valid motor vehicle insurance policy in effect on the date of the violation.
4. Not have occurred in a school zone w/children present.
5. Not have occurred in a construction zone w/ worker's present.

Offenses eligible for amendment without a court appearance and the associated fines (including court costs) to amend are as follows:

<u>Offense:</u>	<u>Amended fine and costs:</u>
Speeding: 5-19 mph over speed limit	\$225.00
Over 20 mph – Attorney needs to come to Court and see Prosecutor	

Additional fine if:

Construction zone (no workers present)	\$100.00
School zone (no kids/teachers present)	\$100.00

Stop Sign Violation	\$225.00
Red Signal Violation	\$225.00
Fail to Maintain a Single Lane	\$225.00
Turn Signal Violation	\$225.00
Following too Close	\$225.00
Excessive Acceleration	\$225.00
Failure to Appear	\$103.00

1. A separate written entry of appearance by counsel; if not already filed with the court
2. **Email Address** for delivery of a return receipt;
3. **CREDIT CARD ONLY.**

Court Costs are \$27.50 effective 7/1/17

*** CASH OR CHECKS WILL NOT BE ACCEPTED FOR WALK-INS **UNLESS ON COURT NIGHT*****

ON COURT NIGHT- YOU MAY BY-PASS THE PROSECUTOR LINE, COME DOWNSTAIRS TO CLERK AND PAY IN ANY FORM AS THE PROSECUTOR WILL APPROVE THAT EVENING
